TCM distributes child ID kits and safety publications to children, parents, and educators; provides safety education to teach children how to stay safer in real life and on the internet; teaches parents how to safeguard their children in real life and on the internet and what to do if their child goes missing. 2015 services included: distributing 8,841 Safety Brochures and 2,962 Child ID Kits; presenting 291 child safety presentations attended by 23,434 children and 3,057 adults.

TCM provides services and support to law enforcement officers and agencies through training and Amber Alert issuance. 2015 services included: issuing 13 Amber Alerts for 17 missing children, all but one of whom were located safely; providing 15 local Law Enforcement trainings and presentations for 232 officers representing 22 agencies.

TCM provides case work, search, and case management to aid the recovery of missing persons and to facilitate the healing process for missing persons and their families. 2015 services included: working 134 cases involving 84 missing children, 62 missing adults, and serving 183 family members.
