TCM distributes child ID kits and safety publications to children, parents, and educators; provides safety education to teach children how to stay safer in real life and on the internet; teaches parents how to safeguard their children in real life and on the internet and what to do if their child goes missing. 2017 services included : distributing 11,274 Safety Brochures and 3,188 Child ID Kits; presenting 143 child safety presentations attended by 34,994 children and 3,849 adults.

TCM provides services and support to law enforcement officers and agencies through training and Amber Alert issuance. 2017 services included: issuing 6 Amber Alerts for 6 missing children, all of whom were located safely; providing 6 local Law Enforcement trainings and presentations for 90 officers representing 13 agencies.

TCM provides case work, search, and case management to aid the recovery of missing persons and to facilitate the healing process for missing persons and their families. 2017 services included: working 280 cases involving 79 missing children, 201 missing adults, and serving 299 family members.
