

Texas Center for the Missing (TCM) is a Houston-based non-profit and is the Amber Alert provider for the 14-county Houston-Galveston region. TCM offers crisis intervention, prevention, and community education services related to child abductions, runaways, internet lures, and endangered adults. To decrease the numbers of missing children, we at Texas Center for the Missing know that children and families need to be educated about how to remain safe, law enforcement needs to be trained on how and when to issue local Amber Alerts, and the community at large needs to be aware of the painful reality of these situations. Since its founding in 2000, TCM has directly served more than 180,000 children and families. In addition, TCM has trained 6,500 law enforcement officers and provided assistance in more than 800 missing persons cases. We are at the ready to activate community resources 24/7 to get a missing child or endangered adult home quickly and safely. Your support directly affects our ability to serve the Greater Houston community with the best and most time efficient resources available.



Creating an Impact:

TCM teaches children how to protect themselves and teaches parents how to monitor their children more effectively both online and on the street.

A partnership with the Houston Metro Internet Crimes Against Children Task Force provides training to volunteers to implement these life-saving presentations.

Preparing Law Enforcement:

As the sole provider of Amber Alert issuance training in our region, we trained 299 law enforcement officers last year alone. You are helping us ensure our local law enforcement officers have the tools and resources they need to bring a missing child home.

A grant from the Houston Young Lawyers Foundation funded the creation and distribution of the Digital Law Enforcement Missing Persons Resource Kit.

Ensuring Rapid Response:

Each year, we get faster and better at responding to the needs of the families of the missing by issuing Amber Alerts quickly and by more effectively utilizing existing networks of people and services to assist when families need it most.

A generous gift from two families created the Safety Savvy Mobile App so that searching families have resources at their fingertips on Android and Apple devices.

- In celebration of National Missing Children's Day, Clear Channel sponsored the digital billboard featured above as an in-kind gift to the community.
- TCM's new website was launched in early 2014 featuring a Crisis Intake Management Form made possible by a United Way Community Building Grant.
- TCM's New Donor Management System now makes online giving easier and more streamlined -- and secure -- for donors.
- Texas Center for the Missing was selected as a beneficiary agency of Fluor Golf for Greater Houston receiving \$64,600 -- the single largest corporate gift in our history!
- TCM's Safety Savvy Mobile App was unveiled in late 2014.
- The ChevronHouston Marathon Run for a Reason Program raised over \$24,210 for TCM Programs.

Houston Regional Amber Alert System

In 2014, TCM issued 20 Amber Alerts for 24 at-risk children with 23 recovered safely!

There is no national system for Amber Alert issuance. Each region relies on local resources to successfully implement the recommended national guidelines. Texas Center for the Missing serves as the Administrator for the Houston Regional Amber Alert System.

Texas Center for the Missing provides the training and activates all local Amber Alerts via a web-based platform designed by Virtual ArchiTechs specifically for the Houston-Galveston region.

Through 2014, the Houston Regional Amber Alert System has issued 159 Amber Alerts for 195 endangered missing children with a 94% rate of safe recovery and is credited with the safe recovery of 81 children out of the 767 recoveries directly attributed to the Amber Alert nationwide.




