Senior Police Officer/Detective Darrin Buse, Houston Police Department – Missing Persons Unit

Darrin Buse is a Senior Police Officer/Detective and has served with the Houston Police Department for over 29 years. Detective Buse has served as a Detective in the Missing Persons Unit for over 24 years. Officer Buse has investigated missing person cases involving children, adults and persons of all ages with special needs including a great number that involved searching for persons that have been diagnosed with or were reported to have Alzheimer's/dementia. Detective Buse also conducts training for his department on topics regarding missing persons/children cases. Detective Buse is a U.S. Army veteran and has a Bachelor's degree in Organizational Leadership. Detective Buse is a certified TCOLE Instructor for the State of Texas.

Felony Chief Prosecutor Lisa Calligan, Harris County Assistant District Attorney

Lisa Calligan is a Felony Chief Prosecutor who has been an Assistant District Attorney in Harris County, Texas, since November 2006. Throughout her career, Lisa has been assigned to a number of different positions within the Harris County District Attorney's Office, including positions in the Felony Trial Bureau, the Juvenile Division, the Family Criminal Law Division and the Child Abuse Division. She is currently assigned to the Major Offenders Division of the Special Prosecutions Bureau. Her current position primarily involves assisting law enforcement agencies in the investigation of violent criminal offenses, as well as managing a docket of serious felony cases in the Harris County District Courts.

Special Agent Glenn Gregory, Federal Bureau of Investigation (FBI), Houston Division Violent Crime Task Force

Special Agent Glenn Gregory was appointed as a Special Agent with the FBI in November of 1996. Since that time SA Gregory has continually been assigned to the FBI Houston Division Violent Crime Task Force, which is comprised of investigators from the Houston Police Department (HPD), Harris County Sheriff's Office (HCSO), Texas Department of Public Safety, and FBI Special Agents. SA Gregory has served as the Houston Division Kidnapping Coordinator since 2002, and as Houston Division's primary National Center for the Analysis of Violent Crime Coordinator since 2005. SA Gregory has served as the FBI liaison to the HPD Homicide Division since 2002, and has worked extensively with the HPD Homicide Division and the HCSO Homicide Unit on numerous child abduction, ransom kidnapping investigations, and various homicide investigations. Prior to

his employment with the FBI, SA Gregory served for eight years on active duty in the United States Marine Corps.

Sergeant Apolito Hernandez, Harris County Sheriff's Office, Investigations Bureau

Sergeant Apolito Hernandez is a 14-year veteran with the Harris County Sheriff's Office. He began his career as a patrol deputy and worked his way from Field Training Officer to Sergeant. Sergeant Hernandez has worked various assignments in detentions, including supervision of the Records Bureau. He is currently assigned to the Investigations Bureau where he oversees cases involving Missing Persons and Runaways. Under Sgt. Hernandez's supervision, his small team of four investigators has solved and closed over 3,300 cases in the year 2020. In 2021, his team solved a 23-year-old missing persons case and in two other cases located missing persons whose investigations and due diligence lead to homicide charges being filed in both cases.

Dr. Deborrah Pinto, PhD, D-ABFA, Unidentified Case Manager and Forensic Anthropologist, Harris County Institute of Forensic Sciences

Dr. Deborrah Pinto, PhD, D-ABFA, is employed as the Unidentified Case Manager and Forensic Anthropologist at the Harris County Institute of Forensic Sciences (HCIFS). In this role, she assists with identification of unknown decedents as well as conducts scene recoveries and performs anthropological analyses. She has been with HCIFS since 2010. Dr. Pinto is certified by and serves on the Board of Directors for the American Board of Forensic Anthropology.
