TCM distributes child ID kits and safety publications to children, parents, and educators; provides safety education to teach children how to stay safer in real life and on the internet; teaches parents how to safeguard their children in real life and on the internet and what to do if their child goes missing. 2021 services included: distributing 265 Safety Brochures and 120 Child ID Kits; and presenting 43 safety presentations attended by 587 children and 947 adults.

TCM provides services and support to law enforcement officers and agencies through training and Amber Alert issuance. 2021 services included: issuing 3 Amber Alerts for 3 missing children, all were located safely and 14 Silver Alerts for 14 missing seniors all of whom were located safely; providing 15 local Law Enforcement trainings and presentations for 344 officers.

TCM provides case work, search, and case management to aid the recovery of missing persons and to facilitate the healing process for missing persons and their families. 2021 services included: working 256 (includes persons for whom Amber and Silver Alerts were issued) new missing person cases involving 94 missing children, 145 missing adults, and serving 3,072 family members.
